Important notes for Traders and Caterers

1. Stands £105 and under - Full payment on application is required.

Stands over £105 - 50% non refundable deposit required with Booking Form - Full balance must be paid by 31st July.
Late bookings (advisable not to leave too late as we fill the showground) - Bookings after 1st July payment in full required by all applications.

3. Trade passes will be available from 1st August.

4. Pick a Stick, Microphones and Speakers are not allowed without written permission– any stands with loud bangs etc must notify us so they can be situated accordingly for the comfort of visiting dogs.

5. All stands must hold insurance and Risk Assessment - Copy of documents to accompany initial payment.

6. Please note the water restrictions - see T&C's
